I am writing to express my strong support for Dr Fiest's grant application titled "Understanding the effects of visitation policies on critically ill patient," in my capacity as Scientific Director of the Canadian Critical Care Society (CCCS).

Dr. Fiest is an esteemed member of the Canadian Critical Care Society. Her team's proposed update to a natural language processing algorithm to include virtual visitation is an innovative approach to understanding the effects of restricted ICU visitation policies on patient and health system outcomes. Through the use of electronic medical record data, their work aims to provide crucial insights into this important issue.

Dr. Fiest and her team have already made significant contributions to our understanding of the impacts of family presence through the development and validation of a natural language processing algorithm to measure the frequency and mode of family presence in Alberta ICUs and a research program to describe the impacts of restricted family presence on patients, families, and ICU clinicians. Their commitment to compassionate and thoughtful engagement with the patient partners, families, and healthcare experts will ensure the perspective of all impacted groups is reflected in all grant deliverables.

The CCCS fully supports this important work and is committed to providing inkind contributions over the period of the proposal. This includes:

- 1) Providing access to CCCS resources and clerical support to identify and liaise with relevant experts and knowledge users in the Canadian critical care community.
- 2) Advising and supporting the team to develop dissemination materials through our Knowledge Translation Committee and Clinical Committee.

The COVID-19 pandemic highlighted the impact of restricted ICU visitation policies on patient and health system outcomes, making this proposed research especially timely and important.
